Position Brief

To deliver frontline services to Transgender and Gender Diverse survivors of domestic and family Violence.

The primary purpose of the role is the provision of specialised client focused case management to survivors of domestic and family violence. The caseworker will address the complex social and legal needs of the client including safe referrals, general assistance, risk assessment safety planning, and support in attending Court as well as other services not specified above.

The position requires travel between the office and other locations on a frequent basis as a normal part of duties. The Domestic & Family Violence worker works closely with the homelessness case management team and is responsible for establishing and providing a comprehensive range of case work initiatives to survivors of Domestic and Family Violence.

The Gender Centre is an Equal Opportunity Employer and does not discriminate in regard to race, age, cultural or religious background, disability, gender, gender identity/expression, or sexual orientation. All qualified candidates of all backgrounds are encouraged to apply.

Duties to be undertaken:

- 1. Manage a case load of survivors of domestic and family violence, directly through initial contact, and risk assessment
- 2. Undertake face to face emotional support and provide advice, information and advocacy
- 3. To establish multi-agency partnerships including local government and NGO's and work with local agencies whose services clients may require, such as housing, and health providers.
- 4. Undertake documented safety planning with clients to address their immediate safety needs
- 5. Provide assessment, case planning and coordination of services to meet the needs of the client
- 6. Fulfill data collection , administration and reporting requirements in line with our Service Agreements
- 7. Maintain client records and case notes, electronically, in a professional manner as per service policy.
- 8. Ensure that the experiences of service-users inform the development and delivery of services through Your Experience of Service (YES) Surveys and keeping accurate data and statistics.

Essential criteria for this position

- 1. Must have a Diploma in Community Welfare or other relevant educational qualifications as well as 3 years' experience working within the Domestic Family Violence space
- 2. Demonstrated understanding of the issues related to domestic violence, the criminal justice response to domestic violence, legislation in relation to apprehended domestic violence orders and an understanding of the family law system and child protection system
- 3. Demonstrated Experience of direct service delivery to victims of domestic abuse and those effected by domestic abuse, including face-to-face support
- 4. Demonstrated experience in prioritising a challenging and demanding workload; managing stressful situations; and applying advanced reasoning skills and independent professional judgement when dealing with situations of a novel or critical nature
- 5. Experience of advocacy with other agencies,
- 6. Demonstrated effective crisis, early intervention and complex case management using strengths-based, trauma-informed and holistic approaches
- 7. Integrated understanding of specific issues for marginalised clients (First Nations people, culturally and linguistically diverse (CALD) backgrounds, Transgender and Gender Diverse people experiencing domestic or family violence).
- 8. Well-developed interpersonal skills (non-judgmental, non-discriminatory, nondictatorial) as well as maintain confidentiality within a small community

Writing your application
